

PARTICIPANTS RECEIVE A 45-DAY RESIDENCY AND ARE OFFERED THREE MEALS PER DAY. HIGHLIGHTS FROM 2019-2020 FISCAL YEAR: PROVIDED SHELTER FOR 45 MEN, 25% WERE EMPLOYED AT ANY LEVEL WHEN THEY ARRIVED, 60% FOUND EMPLOYMENT WHILE IN THE PROGRAM, PROVIDED OVER 9,000 MEALS TO EMERGENCY SHELTER PARTICIPANTS. ADDITIONALLY, HELPED THE COMMUNITY BY FIELDING OVER 200 PHONE CALLS FROM INDIVIDUALS LOOKING FOR ASSISTANCE. HELPED PEOPLE LOCATE AFFORDABLE HOUSING OPTIONS, THEREBY PREVENTING HOMELESSNESS IN SOME CASES. 100% OF PARTICIPANTS WOULD RECOMMEND GOOD SAMARITAN SERVICES TO A PERSON IN NEED.
